**Terms and Conditions:**

- i. **Age:** 35 to 65 years as on 01/04/2022; Age proof certificate to be submitted.
- ii. **Educational qualification:** Degree in Child Psychology, Psychiatry or Law or Social Work or Sociology or Human Health or Education or Human Development or Special Education for Differently Abled Children. Preference will be given to the Post Graduate degree holders in the mentioned subject.
- iii. **Experience:** Actively involved in Health, Education and Welfare activities pertaining to children for seven (7) years or is a practicing professional with the above-mentioned degrees.
- iv. A person shall not be eligible for selection, if he/ she
  - a. has any past record of violation of Human rights/ Child rights
  - b. has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offense.
  - c. has been removed or dismissed from service of the Govt. of India or State Govt. or an undertaking or corporation owned or controlled by the Central or State Govt.
  - d. has ever indulged in child abuse or employment of child labour or has committed any immoral act or any other violation of human rights.
  - e. is involved in the management and/ or associated (directly or indirectly) in any Child Care Institution

- v. An existing Chairperson/ Member of any Child Welfare Committee cannot apply for the post of Chairperson/ Member in any Child Welfare Committee again for a consecutive term
- vi. An existing Social Worker of any Juvenile Justice Board cannot apply for the post of Social Worker in any Juvenile Justice Board again for a consecutive term
- vii. Appointment of any Member or Committee shall be terminated by the Govt after making an enquiry if he/ she has been found guilty of misuse of power vested on them under this Act, if he/ she
  - a. has been convicted of an offense
  - b. fails to attend the proceeding of the Committee or Board consecutively for 3 months without any valid reason or fails to attend  $\frac{3}{4}$  of the sittings in a year
  - c. holding such other full-time occupation that does not allow him to give necessary time and attention to the work of the Board or Committee.
  - d. does not fulfil the qualifications and experience prescribed in the Act and rules made there under and in such a case, the Selection Committee, constituted under Rule 87 shall after due inquiry and on establishment of such fact, reject his application and recommend the name of the next person from the list of names prepared for filling the vacancies.
  - e. Any practicing lawyer/ advocate selected for any of the positions in JJB or CWC shall be debarred from dealing with any case relating to children (below 18 years of age) during their tenure in CWC or JJB even in their personal capacity
  - f. All selected Members shall have to undergo police verification

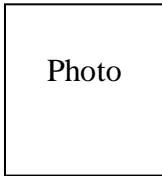
The Chairpersons or Members of CWC and Social Workers in JJB shall be paid **Rs.1,500/-** (Rupees Fifteen Hundred) only per sitting (minimum 6 hours in a day).

Willing and eligible applicants may submit their applications along with a self-declaration certificate by **22nd July, 2022** during office hours in the office of the District Child Protection Officer of the district concerned. Copy of the self-declaration certificate is attached with the advertisement.

Applications, complete in all respects, received in the respective districts shall be scrutinized by the District Level Scrutiny Committee (DLSC) and a panel of shortlisted candidates shall be prepared in the ratio of 1:3. Thereafter, it will be placed before the State Level Selection Committee (SLSC), constituted under Rule 87 of Model JJ Rules, 2015 for final approval. The SLSC reserves the right to reject any application or recommendations made by the DLSC as and when required. The SLSC also reserves the right to review their own recommendation in case any complaints are received.
