1. Candidates must not be less than 18 years and not more than 40 years of age as on 01.06.2022. The upper age-limit is relax able up to 5 years for SC/ST and 3 years for OBC/MOBC as per Govt. Rules. The upper age-limit in case of PWD candidates will be as per Govt. Rules.

Candidates must submit their applications on standard form (Assam Gazette Part-IX) addressing to the District & Sessions Judge, Cachar, Silchar mentioning in the envelop "**Application for the post of Grade IV**" either through post or by hand to the **Office of the District & Sessions Judge, Cachar, Silchar**. The candidates who intend to submit their application by hand directly shall drop their applications in the drop box which will be kept in the 1st floor of the new court building adjacent to Chief Administrative Officer's chamber from 10:00am to 05:00pm in the working days w.e.f. 12-8-22 to 31-8-22.

Applications must be submitted with self-attested copies of all testimonials/certificates in support of age, educational qualification and caste etc., (**Candidates must furnish certificates in respect of special skills**) along with 4 (four) recent passport size photographs with the application with MOBILE NUMBER preferably, Whatsapp number.
4. Candidates serving in Govt. Departments must submit their applications through proper channel.
5. Applications must reach the Office of the District & Sessions Judge, Cachar, Silchar during office hours on or before **31-8-22**. No application will be entertained beyond the said period. The undersigned shall not be responsible under any circumstances for any postal delay..
