- (2) After scrutinizing of the documents, the selected candidates shall be called for personal interview, to be conducted at Head Office of Pollution Control Board, Assam, Bamunimaidam, Guwahati-21.
- (3) Local candidates i.e. candidates belong to the nearby area of the NAMP Station, shall be given preference in the selection of the candidates.
- (4) The Board reserves the right not to fill up the posts; and in such a situation, no correspondence/representation will be entertained.
- (5) Candidates can appear for more than one post. Candidates shall clearly indicate the name of post for which they are appearing for interview.
- (6) The experience specified above shall be the experience acquired after obtaining the basic/essential qualification for the post.
- (7) The last date of submission of duly filled application is 20-08-2022 to Pollution Control Board, Assam, Bamunimaidam, Guwahati-21. Application may also be submitted by email at recruitment.pcba@gmail.com in a single pdf file of the application and the annexures.
