## C. Eligibilty Criteria:

#### 1) Qualifying Age:

- Candidates must be within the age limits of 30 years to 65 years on the date of publication of
- Age limit of candidates will be calculated on the basis of Birth Certificate issued by the competent authority, HSLC Admit card / Certificates issued by recognized Board/Council.
- No other documents shall be accepted in lieu thereof for the purpose.

#### 2) Educational Qualification:

Candidates should be minimum 10th passed from a Board/ Institution recognised by the Sate/Central Government.

#### 3) Other Criteria:

- Candidate should be a citizen of India and a permanent resident of the area in respect of which he/she seeks appointment.
- Candidate should be physically fit and have sound mind.
- Candidate should not have been declared as an insolvent or defaulter in payment of Govt dues.
- Candidate should not be a Government employee.
- Preference shall be given to the family members of Gaon Pradhan and views of the Mouzadar shall be taken into consideration.
- Candidate should have landed property /immovable property in his/her name in the area in which he/she intends to be appointed as Gaon Pradhan.
- Candidate should not be a member of any Political Party.
- · Candidate should be a person of high status and command and have a respectable position in the
- · Candidate should have worked/ volunteered for the advancement of the Government policies and programmes and rendered assistance in natural calamities.
- Candidate should not have more than 2 (two) living children from a single or multiple partner (in cognizance to Government of Assam Notification dated 19th July, 2019 vide No. RLR.187/2007/Pt/24).
- Candidate should furnish a self- affidavit that the applicant does not have more than two living children from a single/multiple partner.

## D. How to apply

- b) The candidates should upload self-attested scanned copies of following documents and please ensure that scanned copies are legible.
  - Educational qualification Certificate.
  - Age Proof Certificate (i.e birth Certificate issued by the competent authority or HSLC Admit Card/ Certificates issued by the recognized Board/ Council.
  - Recent Passport size colour photograph of size 3.5 cm x 4.5 cm with white background.
  - Scanned signature of the applicant.
  - Small Family Norms affidavit/ Self Declaration stating that the applicant does not have more than two living children from a single/multiple partner.(in cognizance to Government of Assam Notification dated 19<sup>th</sup> July,2019 vide No. RLR.187/2007/Pt/24)
  - Mouzadar certificate confirming that the applicant belongs to the village where he/she is applying for the post of Gaon Pradhan.
  - Jamabandi in the name of the applicant/ family member of the concern village where he/ she is applying for the post of Gaon Pradhan.
  - Self declaration stating that he/she does not belongs to any political party and not a Government employee.
  - Bakijai Clearance Certificate.

- The call letters will be available on the above mentioned website and can be downloaded for appearing in "Viva Voce" whose application are accepted as per eligibility criteria.
- It may be noted that no separate call letters will be issued and it will be the responsibility of the applicant to take out the print out.
- Nobody without call letters shall be allowed to enter the interview venue.

- No request for admission for participation in the interview on another day will be accepted in case candidate fails to attend the interview on the scheduled date.
