Roles & Responsibilities:	Chief Administrative Officer is responsible for General Administration of Organization which includes assisting the Director in General Administration & Personnel Management, Vigilance Proceedings, Grievances, RTI matters, Handling the legal & Security matters, construction activities, Convening & Coordinating for various Assessment Committee, Preparation of Agenda notes and Minutes of the meetings and follow up action to implement its decisions etc. He/She will also be the Secretary to the Board of Directors. Candidates currently serving State / Central Government / PSUs can apply on deputation.

Probation for the post will be initially for a period of 1 year, extendable to 5 years based on performance.

Instructions to the Candidates:

- 1. Applications shall be submitted **before 4:00 PM on-line latest by 23rd July, 2023.** The application can be had from www.iiitmk.ac.in/careers.
- 2. IIITM-K has the right to reject the entire selection/advertisement procedure at any stage and the decision of IIITM-K shall be final in this regard
- 3. All qualifications educational mentioned should from а University/Institution/Board recognized by Govt. of India/approved by UGC/AICTE/State Governments. Mere fulfilling of minimum qualifications and experience will not entitle the candidates to be shortlisted for interview. In the event of number of eligible applications being large, IIITM-K reserves the right to shortlist the candidates to be called for further process as per academic merit and experience for the post in the ratio as determined by IIITM-K, which will be final and binding.
- 4. Reservation Rules are applicable for SC/ST candidates as per the Government of Kerala norms.
- 5. The posts carry service contribution/Leave /Medical benefits and allowances as per Government of India norms.
- 6. The candidates must bring all original certificates/testimonials at the time of the interview.
- 7. Incomplete applications / applications without necessary attachments may not be accepted.
- 8. Any misleading wrong information supplied by the candidates may lead to summary rejection of the application, if found subsequently also, the appointment will be canceled.
- 9. Persons employed in Government and Semi-Government organizations must apply through the proper channel. 'No Objection Certificate' shall be submitted along with the application.
- 10. No interim queries regarding interview/selection process will be entertained.
- 11. Canvassing in any form will lead to the rejection of the application form.
- 12. Decision of the selection committee and the Board of Directors of IIITM-K with respect to the selection process is final.
- 13. Candidates will have to appear for interview at their own cost, if called before a selection committee on the date and place which will be communicated to the candidates.
